The meeting was called to order by Mayor Cecil at 5:00pm. The pledge was recited.

Lois made a motion to appoint **Ruth Faulkner to fill the empty seat on the Board of Commissioners**. Linda seconded the motion. All voted in favor. Motion carried.

Mayor Cecil administered the "Oath of Office" to Ruth Faulkner.

Linda made a motion to appoint Ruth to be the **department head for the Street department**. Lois seconded the motion. All voted in favor. Motion carried.

The **Meeting Minutes of August 15<sup>th</sup>, 2019** were approved with a motion by Linda and a second by Lois. All voted in favor. Motion carried.

The **August Financials and July Bills** were approved with a motion by Linda. Lois seconded the motion. All voted in favor. Motion carried.

#### **New Business**

Joanie asked the board to approve the new rental fee of \$150, with a refundable deposit of \$50 for the use of the Tessie R. Cecil Pavilion. The refundable deposit would change from \$75 to \$50. The \$25 will be used to pay Letitia Nalley to clean the restrooms in **Barry Hall** after a rental. When the pavilion is rented, the renters are allowed to use the Barry Hall restrooms. Linda made a motion to accept the new **pavilion rental fee**. She also stated that complimentary rentals will also be required to pay the \$25 cleaning fee. Lois seconded the motion. All voted in favor. Motion carried.

Ideas and suggestions were discussed on what the City should do with the building located at 144 **Main Street**, which is owned by the City. No action was taken.

Joanie asked the board to consider offering our local businesses a "Business Beautification Grant". The grant would be for renovations/improvements for the outside of their building to help beautify our city. The grant would be a matching grant, up to \$300 per business. The grant could be used for things such as, paint, landscaping, signs and pressure washing. An application would have to be submitted and a committee would review the application to approve or disapprove. If the expense was approved, a receipt would have to be provided to the City after the work was complete and a reimbursement check

would be issued. Joanie stated that she would like to ask the Community Development Committee to

add money to the budget for the grants.

After a short discussion, Linda made a motion to approve \$6000 for the "Business Beautification" grant

and to approve a committee consisting of Joanie Corbin, David Nalley and Ruth Faulkner. Ruth

seconded the motion. All voted in favor. Motion carried.

Joanie reported that the City would be hosting the Christmas Parade this year. The parade will be on

Sunday, December 8<sup>th</sup> @ 5:45PM. Mr. & Mrs. Claus will visit with the children at City Hall immediately

following the parade. Joanie & Angela will also be working on revamping "Light up New Haven" at

Simms' Park.

Tessie reported that the City had been awarded a grant of \$4500 from the Bardstown-Nelson County

Tourist and Convention Center. The funds are restricted and must be used to replace the 4 welcome

signs at each entrance of the City.

Administration

Joanie read Ordinance # 479 Series 2019 - 2019 Property Tax Rate. This was the second reading of the

ordinance. Linda made a motion to approve Ordinance #479 Series 2019. Lois seconded the motion.

Roll Call – Ruth-abstained, Mike – yes, Lois – yes, Linda – yes, Tessie – yes Motion carried.

Linda made a motion to approve **Resolution # 2019-1**, which will impose a 1% administration fee on all

City administered grants. Lois seconded the motion. All voted in favor. Motion carried.

Police/Fire

Fred DeWitt stated that he still has no update on the **FEMA grant**.

Water & Sewer

A motion was made by Linda to enter executive session per KRS 61.810(1)(c) to discuss pending

litigation. Lois seconded the motion. All voted in favor. Motion carried.
