New Business

Wes Bradley, Supt. Of NC Schools attended the meeting to update the board on what is currently in the works for New Haven School.

The **1**st reading of Ordinance # 495 Series 2021 was read by Joanie Corbin setting the 2021 property tax rate.

Administration

The sale of the property at **144 South Main Street** is complete. It was paid for and signed over on July 23, 2021. Nicole asked the board to spend the revenue from the sale of the building on a project that would impact the youth of our community.

There is no update on the franchise renewal with Charter Communications.

Resolution # 2021-4 for "City Government Month" was passed with a motion by Linda and a second by Lois. All voted in favor. Motion carried.

Police/Fire

Fred DeWitt reported that the **fire department** may have to go back to virtual training in the near future.

Water & Sewer

Linda reported that she had met with Matt Baker, the engineer from Cann-Tech. LLC to discuss the **lagoon upgrades.** The upgrade will cost approximately \$500,000. The upgrade will be paid for with ARP funds and other funding sources. No loan will be acquired to complete the project. Linda made a motion for

Linda informed the board that a letter was received from **Larue County Water District** just a few hours ago. She asked the board to table the item until she had time to review the letter and if needed, speak to the attorney.

Linda reported that the **hiring committee** was made up of the following individuals (Linda Mattingly, Lois Boley and Fred DeWitt). The committee completed interviews on Monday, August 16, 2021.

Linda made a motion to enter **executive session per KRS 61.810(1)(f) for discussions or hearings which might lead to the appointment, discipline, or dismissal of an individual employee**. Ruth seconded the motion. All voted in favor. Motion carried.

Linda made a motion to re-enter **regular session**. Ruth seconded the motion. All voted in favor. Motion carried.

Linda made a motion to authorize Mayor Cecil to **hire 1 interim Public Works Director and 1 interim Water & Wastewater Supt.** She stated that the names would not be released until they accept the job offer. Ruth seconded the motion. All voted in favor. Motion carried.

There was a short discussion about the **"No Parking Sign"** that was installed on Center Street in front of the New Haven Library. No action was taken.

Recreation

Linda made a motion to get quotes on **painting the bathhouse at the pool and Barry Hall and for replacing the gutters on Barry Hall.** Mike seconded the motion. All voted in favor. Motion carried.

Historical Preservation/Informational Center/Military/Veterans Center

The building **renovation** is complete.

Ruth made a motion to **adjourn** the meeting. Linda seconded the motion. All voted in favor. Motion carried.
