New Business

provide free locations, but will be asking for a canned food donation for the "Blessing Box".

Joanie presented the quote from First Insurance Group for the city's liability insurance and worker's

compensation insurance for the 22/23 policy year. The liability insurance will be \$ 16,510.94 and the bill

from KEMI will be \$4,732.10. Linda approved the insurance expenditure for the upcoming year's policy.

Ruth seconded the motion. All voted in favor. Motion carried.

Police/Fire

Lois reported that starting next week, the **Nelson County Sheriff's Office** will be available to cover New Haven. Linda made a motion for the city to enter into a **contract** with the Nelson County Sheriff's office to provide police coverage in the city limits of New Haven. Ruth seconded the motion. All voted in favor. Motion carried.

Fred reported that the **fire department merge contract** in in the hands of an attorney at this time. He hopes to present it to the New Haven Board of Commissioners in July.

Fred stated that the Nelson County Fiscal Court has \$35,000 in their budget to replace 2 sirens in Nelson County. **New Haven's weather alert siren** will be replaced.

Water & Sewer

The 2nd reading of **Ordinance 499- Series 2022 – Water/Sewer Rates** was read by Joanie. Linda made a motion to approve Ordinance #499 – Series 2022. Lois seconded the motion.

Roll Call – Ruth Faulkner – aye, Lois Boley – aye, Linda Mattingly – aye, Tessie Cecil – aye All voted in favor. Motion carried.

Linda reported that Kenvirons, Inc. has started the paperwork and initial surveying for the **lagoon upgrade** project. More information will be provided at the July meeting.

Ordinance #502 Series 2022 – Sewer Rates (Log Still Distillery & the Abbey of Gethsemani) was read by Joanie. The second reading will take place in July.
